5) Jurisdiction of Trust - Entire Maharashtra.

- 8) Trusteeship A Trust.

1) Any adult Indian accepting aims and policy of trust of trust on depositing prescribed yearly subscription of Rs. 1000/- (Rupees one thousand only) can become member however, The Decision of executive body about the membership will be final. Life member Ship will be given on depositing Rs. 5000/- on depositing Rs. 3000/- (Three Thousand Rupees Only.) general membership will be given. Well wisher membership will be given on depositing Rs. 1500 (Rupees one Thousand Five Hundred) However it is incumbent to have recommendation of at least two trustees of trust on the application seeking membership of all kinds. After such recommendation only on approval of application unanimously the member will get membership of the trust.

- 2) It will be entirely within the discretiori of the body of the trust either to grant or refuse membership of trust.
- 3) For economic development of the trust the institution can obtain financial assistance from co-operative or natitionalized bank, and by hypotheting moveable and immoveable property, out of the income of the institution it will be repaid Donors will not acquire rights in public trust body.
